The State of Alaska has reviewed the proposed land bank agreement with Paug-Vik Incorporated Limited. This agreement would place approximately 121,000 acres of land near the village of Naknek in the Alaska Land Bank Program.

We appreciate incorporation of the generic language at Sections 8(d), 12, 14(f) and 15(d) as previously agreed. The Department of Fish and Game operates and maintains a salmon escapement counting tower in the SE1/4 NW1/4 Section 14, T 18 S, R 44 W, SM, and wishes to be assured that this facility will remain available for fisheries management purposes, notwithstanding the land bank agreement. The Department of Transportation and Public Facilities has noted that airport lands at North Naknek Airport appear to be included in the proposed land bank agreement. These lands, however, were conveyed by Paug-Vik Incorporated Limited to the State of Alaska in 1984, pursuant to Section 14(c)4 of the Alaska Native Claims Settlement Act (see enclosed deed). Accordingly, the conveyed lands should be deleted from the proposed land bank agreement.

Thank you again for the opportunity to review the proposed agreement.
