Introduction:

The Alaska Department of Natural Resources (ADNR) – Division of Mining, Land & Water (DMLW) is assembling a list of businesses who provide vessel salvage services and wants to know if your business provides such services. DMLW is currently creating an Abandoned and Derelict Vessel (ADV) public website which will host a list of resources for vessel removal, including a list of businesses providing a range of vessel salvage services, around the state.

Details:

When considering whether your business qualifies for this list, consider the following questions. If the answer to any of these is yes, your businesses is likely eligible to be included on the list. Please note, the below list is not all encompassing, if you do not answer yes to any of the below questions but believe your business should be included on the list, please contact us. This is an open and continuous request for information. Interested parties may submit their business information for evaluation at any time, until further notice.

- Is your business capable of raising sunken vessels?
- Does your business have the infrastructure to remove large vessels from the water?
- Is your business capable of breaking down and disposing of vessels once they are on land?
- Is your business capable of providing towing services for vessels?
- Is your business capable of conducting underwater surveys to locate and examine vessel status?
