# Office of History and Archaeology news

The Office of History and Archaeology is recruiting for an Archaeologist 2 to work in the Review/Compliance Unit to review development or improvement projects that are federally and/or state licensed, funded, permitted, or on federal and/or state land for potential impacts to prehistoric and historic properties. The individual will also serve as Cultural Resource Liaison with the Department of Transportation and Public Facilities. The position will be the point of contact for DOT&PF Cultural Resource Management staff and will review DOT&PF and FHWA projects for potential impacts to historic properties. The position will also provide technical and planning assistance to DOT&PF staff in early project planning, historic property identification efforts, and environmental public meetings.

### Federal Legislation news

Congress passed a Continuing Resolution (CR), which will extend current spending levels until December 16<sup>th</sup>, averting a federal government shutdown. The final CR did not include the permitting reform proposal that was in earlier versions of the CR.

### National Park Service news

The National Historic Landmarks Program announced the release of a new theme study, "Protecting America: Cold War Defensive Sites." Prepared by John S. Salmon (a National Conference of State Historic Preservation Officers (NCSHPO) consultant with the assistance of the Cold War Advisory Committee, the study considers the Cold War period to be from the detonation of the first two atomic bombs in 1945 to the dissolution of the Soviet Union in 1991. The historic context section introduces the ways in which international affairs and the political and military challenges of the Cold War era influenced the weapons systems and defense programs of the United States. A study includes 24 potential Cold War NHLs for consideration. This and other NHL theme studies can inform National Register of Historic Places nominations.

**Technical Preservation Services** (TPS), National Park Service, has released the <u>Annual Report on the Economic Impact of the Historic Tax Credit for Fiscal Year 2021</u>. A <u>National Park Service press release</u> highlighted the \$7.7 billion in GDP and 135,000 jobs generated by the credit in FY 2021. TPS collaborates with the Rutgers University Edward J. Bloustein School for Planning and Public Policy to prepare the report.

The report highlights the annual positive economic impacts resulting from the Federal Historic Tax Credit and includes information on the cumulative economic impacts since the certification of the first completed rehabilitation project in 1978.

### **NPS Grant opportunities:**

The National Park Service is now accepting applications for the <u>Save America's Treasures</u> (SAT) grant program. The SAT program provides preservation and conservation assistance to nationally significant historic sites and collections. \$26.5 million will be competitively awarded. A dollar-for-dollar, non-Federal match, is required, this can be either cash or documented in-kind services. SAT is administered by the National Park Service (NPS) in partnership with the <u>National Endowment for the Arts</u> (NEA), the <u>National Endowment for the Humanities</u> (NEH), and the <u>Institute of Museum and Library Services</u> (IMLS). Preservation projects fund physical preservation of historic buildings, sites, structures, and objects. Collection projects include conservation of artifacts, museum collections, documents, sculptures, and works of art.

The National Park Service has a new grant program that is accepting applications: Alaska Native and Native Hawaiian Culture and Arts Development Grant Program.

The Secretary of the Interior is authorized to make grants for the purpose of supporting programs for Native Hawaiian or Alaska Native culture and arts development to any private, nonprofit organization or institution which—(1) primarily serves and represents Native Hawaiians or Alaska Natives, and (2) has been recognized by the Governor of the State of Hawaii or the Governor of the State of Alaska, as appropriate, for the purpose of making such organization or institution eligible to receive such grants. Grants will enhance culture and art programs, including traditional and contemporary expressions of language, history, visual and performing arts, and crafts.

Public Law 117-103, the Consolidated Appropriations Act, 2022, provides \$250,000 in Fiscal Year 2022 to encourage new entities to apply. **Closing date for applications: October 31, 2022.** Notice of Funding Opportunity (NOFO) is P23AS00023. Search Grants | GRANTS.GOV

Advisory Council on Historic Preservation Vice Chairman Jordan Tannenbaum signed the Memorandum of Agreement (MOA) on Native Languages on September 28, 2022, at the National Building Museum in Washington, D.C. Reno Franklin, the ACHP's Indian Tribe and Native Hawaiian Member, and Ira L. Matt, the ACHP's Director of the Office of Native American Affairs, witnessed the signing. Lead signatory agencies for the MOA include Dept. of Interior, Dept. of Agriculture, Health and Human Services, and Dept. of Education.
